### **DGJG new parking ground became operational on 14<sup>th</sup> May, at 8.30 AM**

Dear Valued Members,

#### **Greetings from Dubai Gold & Jewellery Group!**

As per the government instructions, Dubai Gold & Jewellery Group **has officially vacated the old parking grounds on 13<sup>th</sup> May (Wednesday, at 7 PM) and the new parking space is operational from 14<sup>th</sup> May 8.30 AM and the service is going on smoothly. Kindly remove your cars from the old parking grounds as it may invite penalty by the RTA/Municipality henceforth.**

#### **Free Shuttle service from the parking ground to and from gold souk**

Considering the distance from the proposed parking area to the gold souk, DGJG will be organizing shuttle service for the members to pick and drop passengers back and forth from parking ground to the gold souk. We request the users to cooperate with the driver and co-passengers while availing the service.

- The shuttle service will operate in **10 minutes frequency** (with two 16 seater buses by a professional transport company) from **Saturday to Thursday between 8.30 am to 11 pm and Friday between 4:30 PM to 11 PM**
- Shuttle buses will have a Dubai Gold & Jewellery Group's name board for identification and will be parked in RTA parking at the main entrances of gold land and gold center buildings (picture of the shuttle bus is attached)

**DGJG seaside parking sticker fee structure (per membership)**

- 1<sup>st</sup> sticker: AED 1250
- 2<sup>nd</sup> sticker: AED 1750
- 3<sup>rd</sup> sticker AED 2250
- AED 50 is applicable per sticker as processing fees\*

**The following documents are required to be submitted for availing the DGJG 2015 parking stickers:**

- ❖ Copy of RTA car registration card for the respective car
- ❖ Copy of labour card of car owner if the car is not owned by the member company (Proof of employment with DGJG member firm)

Existing DGJG members who have not renewed their memberships are requested to do so and purchase the parking sticker for 2015 at the earliest to continue using the parking ground. **Please note, no cars without 2015 stickers will be allowed in the new parking ground.** The parking sticker registration form 2015, rules & regulation etc. are attached herewith. ### **Seaside Parking Ground**

### **2015 Rules & Regulations**

- The parking ground is for the exclusive use of Dubai Gold & Jewellery Group (DGJG) members and jewellery industry stakeholders
- Unless the sticker stuck to the windshield (distinctly visible to the security guard managing the parking ground, entry into the parking ground will be denied
- Stickers will be issued from DGJG office from 9:00 AM to 6:00 PM, Saturday to Thursday
- Parking Stickers will only be issued to members who have renewed their annual DGJG membership for 2015 and on submission of all mandatory documents (see below list of mandatory documents)
- The stickers are strictly not transferable and are to be used only for the vehicle whose registration number is supplied at the time of sticker application. The sticker cannot be rotated between multiple vehicles
- Parking Stickers are strictly not to be sold / handed over to any third parties / non jewellery firms and is to be used only by the employees of the member jewellery firm
- Only cars allowed and strictly no pick-ups allowed in the parking ground
- **DGJG does not ensure the continuity of parking services. It is up to the discretion of the Dubai government authorities and in case the parking ground is revoked, DGJG is not liable to pay any refunds.**
- The validity of the sticker is till 31<sup>st</sup> Dec 2015 unless notified /extended in writing by Dubai Gold & Jewellery Group
- The sticker does not ensure availability of parking space in the ground – it will purely be on a first come first served / availability basis.
- DGJG is not responsible for any theft or damage to the vehicle within the parking ground
- Any attempts to duplicate the sticker will be referred to Dubai Police
- All violators will be referred to RTA / Dubai Police, the corresponding parking stickers will be revoked & applicable fines will follow

3. Valid labour card copy (proof of employment with member gold & jewellery firm)
